**ORDER REQUESTING TELEPHONE RECORDS AND
GEO-PRECISION LOCATION INFORMATION**

This matter having come before the Court pursuant to the certified application of the State of Florida, which application requested based upon probable cause that an order be issued authorizing the Disclosure of Telephone Records and Geo-Precision Location information and which Motion alleged that DEFENDANT is a subject of a criminal investigation, and that DEFENDANT is in possession of cellular telephone number (850) 459-0690; and,

This Court having found that Leon County Sheriff's Office Deputy Dawn Dennis has certified to this Court that the information likely to be obtained by such installation and use is relevant to an ongoing criminal investigation related to Homicide; further certified that there is a clear connection between illegal activity and the person whose privacy would be invaded; that there is a reasonable founded suspicion that the targeted telephone line is being used for a criminal purpose; and that the alternative means of investigation have been considered or attempted and that no less intrusive means will be effective in attaining the objectives of this criminal investigation; and this Court having found the same to exist it is therefore;

ORDERED AND ADJUDGED that AT&T (PO Box 24679 W. Palm Beach, FL 33416), and other providers of wire and/or electronic communications services, landlords, custodians, and other persons and entities are hereby authorized and ordered to furnish the Leon County Sheriff's Office, as soon as practicable from the date of this Order:

(1) Provide all subscriber information, including name and address, date account created, account status, e-mail address, alternate e-mail address, serial number(s) of handset(s) (i.e. IMEI, ESN, and/or MEID), subscriber identity number(s) (i.e. ISMI, MIN, and/or MSID), billing and payment history including method of payment, and account comments created during any contact between the subscriber and a sales, billing or service representative.

(2) Provide call detail records with cell site data; including all inbound and outbound communication events (voice, text, internet or packet data) **without content**, dates, times and duration of communication events, originating and terminating cell sites with sector designations, and a listing of applicable cell site locations, sectors, and orientations January 26, 2011 to present.

(3) Provide, upon written request, the names, addresses, billing and credit information of the subscribers of record, whether published or non-published, for the telephone numbers directly identified through this court order


(4) Provide Geo-Precision (GPS, Locator Tools, Latitude/Longitude) Locations and/or E911 or other such precision location assistance if available; signaling and communications processing information, without communications content, sent and received by the target cellular telephone for any form of communication it is capable of, to include: voice, text, internet, and packet data; control channels used for a period not to exceed sixty (60) days from the data of this Order.

(5) This Order and its supporting Application shall be SEALED until further Order of this Court; provided that a copy of this Order may be made available to employees of AT&T (PO Box 24679 W. Palm Beach, FL 33416), and other providers of wire and/or electronic communications services, landlords, custodians, other persons and entities, and the Leon County Sheriff's Office, if necessary, to facilitate their assistance in implementing the provisions of this Order;.

(6) AT&T (PO Box 24679 W. Palm Beach, FL 33416), and other providers of wire and/or electronic communications services, and their agents and employees, landlords, custodians, and other persons and entities ordered hereby to provide assistance to the Leon County Sheriff's Office and/or Leon County Sheriff's Office, shall not disclose to the listed subscriber, lessee or sub-lessee of the above-mentioned telephone number, or to any other person or entity, the existence of this Order and its supporting Application, or of this investigation, unless otherwise ordered by the Court;

(7) The Leon County Sheriff's Office shall compensate AT&T (PO Box 24679 W. Palm Beach, FL 33416), and other providers of wire and/or electronic communications services, landlords, custodians, and other persons and entities who furnish facilities and/or technical assistance pursuant to this Order for all reasonable charges and/or expenses incurred in providing such facilities and assistance; provided that said charges and/or expenses shall be identified and billed to the Leon County Sheriff's Office as attributable to AT&T (PO Box 24679 W. Palm Beach, FL 33416) cell phone (850) 459-0690.

**MOTION FOR AN ORDER REQUESTING TELEPHONE RECORDS AND
GEO-PRECISION LOCATION INFORMATION**

Comes now affiant Investigator Detective Dawn Dennis who is a sworn Law Enforcement Officer with the Leon County Sheriff's Office and applies to this Court for an order Authorizing the Disclosure of Telephone Records and Geo-Precision Location information on the following grounds:

The Leon County Sheriff's Office has an ongoing criminal investigation Case # 11-18445 involving cellular telephone number (850) 459-0690. It is hereby certified that the information likely to be obtained is relevant to the ongoing criminal investigation being conducted by the Leon County Sheriff's Office involving DEFENDANT for the offense of Homicide.

It is certified that there is a clear connection between illegal activity and the person whose privacy would be invaded. It is further certified, as set forth in the affidavit attached hereto and incorporated herein as Exhibit A, that there is a reasonable founded suspicion that the targeted cellular telephone facility is being used for a criminal purpose, and that alternative means of investigation have been considered or attempted and that no less intrusive means will be effective in attaining the objectives of this ongoing criminal investigation. This application is made pursuant to Florida Statutes 934.23(4) and/or (5), 934.32, and Shaktman v. State, 553 So. 2d 148 (Fla. 1989).

It is further requested that this Court order AT&T (PO Box 24679 W. Palm Beach, FL 33416) and other providers of wire and/or electronic communications services, landlords, custodians, and other persons and entities to:

(1) Provide all subscriber information, including name and address, date account created, account status, e-mail address, alternate e-mail address, serial number(s) of handset(s) (i.e. IMEI, ESN, and/or MEID), subscriber identity number(s) (i.e. IMSI, MIN, and/or MSID), billing and payment history including method of payment, and account comments created during any contact between the subscriber and a sales, billing or service representative.

(2) Provide call detail records with cell site data; including all inbound and outbound communication events (voice, text, internet or packet data) **without content**, dates, times and duration of communication events, originating and terminating cell sites with sector designations, and a listing of applicable cell site locations, sectors, and orientations for January 26th, 2011 to present.

(3) Provide, upon written request, the names, addresses, billing and credit information of the subscribers of record, whether published or non-published, for the telephone numbers directly identified through this court order

(4) Provide Geo-Precision (GPS, Locator Tools, Latitude/Longitude) Locations and/or E911 or other such precision location assistance if available; signaling and communications processing information, without communications content, sent and received by the target cellular telephone for any form of communication it is capable of, to include: voice, text, internet, and packet data; control channels used for a period not to exceed sixty (60) days from the data of this Order.

AFFIDAVIT

I, Detective Dawn Dennis, being duly sworn, do hereby depose and say:

I am conducting or participating in a criminal investigation of two Homicides

In summary, the facts are as follows:

On 27 January 2011, this agency received a call for service at 1740 Corey wood Circle. Upon arrival the bodies of 20 year old Laqecia Herring and her 17 year old brother S.C. were discovered inside the residence. Further investigation revealed that the deceased were victims of homicide. Interviews with the victim's family members revealed that Laqecia was approximately 5 months pregnant. The father of the unborn child was reported to be 17 year old Deshon Thomas. Mr. Thomas was reportedly not happy about the pregnancy and requested that Laqecia abort the child. Laqecia declined to abort the child, at which time Mr. Thomas ceased contact with her for approximately 5 months. Mr. Thomas also reportedly blocked Laqecia from access to his Facebook page until recently. Laqecia advised friends and family that Mr. Thomas came to her residence on the evening of Tuesday 25 January 2011, to speak to her about the pregnancy. Laqecia advised Mr. Thomas that she intended to file for child support.

During the search of the residence, Detectives located Laqecia's cell phone. While searching through Laqecia's cell phone, Detectives observed communication between Laqecia and another subject that is listed in Laqecia's phone contacts as "Shon", 850-459-0690. The two text messaged each other numerous times on Wednesday 26 January 2011. These messages to each other indicated that "Shon" wanted to know who would be at Laqecia's house, what time S.C. would be home and that he would come over to Laqecia's house when he got off work. "Shon" is believed to be Deshon Rashard Thomas.
