

STATE OF FLORIDA vs. DESHON THOMAS MEDIA LINE

**ON FRIDAY, JANUARY 28, 2010, AFTER SPENDING 3 WEEKS STRAIGHT IN OVIEDO, I RETURNED TO TALLAHASSEE TO LEARN (VIA MY 17-YEAR-OLD SON, DESHON THOMAS), THAT HIS PREGNANT 20-YEAR-OLD EX-GIRLFRIEND, LAQECIA HERRING AND HER 17-YEAR-OLD BROTHER, STERLING CONNER JR. HAD BEEN FOUND MURDERED IN THEIR RESIDENCE . DESHON DID NOT TELL ME ABOUT THE MURDERS VERBALLY. INSTEAD HE LET ME READ AN ARTICLE ON A LOCAL T.V. NEWS WEBSITE ON THE INTERNET USING HIS CELLPHONE. NATURALLY DESHON AND I WERE HURT. I MENTIONED TO HIM THAT I'D JUST SPOKEN WITH LAQECIA ON MONDAY. HE TOLD ME THAT SHE WAS TEXTING HIM ON WEDNESDAY NIGHT WHILE HE WAS AT WORK. WELL, LAQECIA AND STERLING WERE FOUND THURSDAY MORNING. DESHON TOLD ME THAT HE RECEIVED THE LAST TEXT FROM HER AROUND 11 O'CLOCK. HE SAID THAT SHE'D TEXTED HIM WANTING HIM TO COME OVER TO HER HOUSE. I ASKED HIM DID HE GO OVER TO HER HOUSE AND HE SAID NO. THEN I BEGAN TO QUESTION IF THAT WAS HER SENDING HIM THE TEXTES. THE REASON I THOUGHT THIS WAS BECAUSE WHEN DESHON STARTED SEEING LAQECIA BACK IN SEPTEMBER 2010, HE WAS ASSAULTED BY AN UNKNOWN 38-YEAR-OLD BLACK MALE. THE ASSAULT HAPPENED WHILE HE WAS ON CAMPUS AT TALLAHASSEE COMMUNITY COLLEGE WHERE HE WAS ENROLLED AS A FULL-TIME STUDENT. AT THE TIME WHEN I LEARNED OF THE ASSAULT, I THOUGHT THAT MAYBE IT WAS BY A DISGRUNTLE EX-BOYFRIEND OF LAQECIA'S. WHEN DESHON TOLD ME THAT HE DIDN'T BELIEVE IT TO BE, I WAS UPSET BECAUSE HE'S DATED GIRLS THAT HAS BLATANTLY LIED TO HIM IN THE PAST AND I FELT LIKE—OK HERE WE GO AGAIN. SO NOW WITH HER TEXTING HIM ONE NIGHT AND THEN BEING FOUND MURDERED THE NEXT MORNING, I WAS THINKING OK, THIS IS SERIOUS! DESHON DID NOT SEEM TO THINK SO. I WASN'T SURPRISED BECAUSE HE HARDLY EVER THINKS THAT SOMETHING BAD CAN HAPPEN TO HIM. HE'S ALWAYS HAD THIS NON-CHALANT TYPE OF ATTITUDE ABOUT THINGS THAT I FELT WERE SERIOUS. AFTER WE DISCUSSED THAT SITUATION, HE INTURN TOLD ME THAT HE FELT LIKE THE POLICE WERE FOLLOWING HIM. HE TOLD ME ABOUT AN INCIDENT WITH THE POLICE THAT HAPPENED THE NIGHT FOLLOWING THE MORNING WHEN THE VICTIMS WERE DISCOVERED. SO NOW I'M THINKING OK, NOT ONLY AM I DEALING WITH THINKING THAT IT'S A POSSIBILITY THAT THERE'S A DISGRUNTLE BOYFRIEND OR WHATEVER AFTER MY SON, NOW THE POLICE ARE HARASSING HIM TOO. ALTHOUGH DESHON DIDN'T KNOW HOW THE VICTIMS WERE MURDERED, I TOLD HIM THAT IF THE POLICE WERE HARASSING HIM THEN THEY MAY HAVE BEEN SHOT. DESHON HAS TWO GUN POSSESSION CHARGES ON HIS JUVENILE RECORD. LONG STORY SHORT, WHEN DESHON WAS 14 AND 15-YEARS-OLD, PARTLY DUE TO

THE IRRESPONSIBILITY OF 2 DIFFERENT LAW ENFORCEMENT OFFICERS, DESHON WAS ABLE TO GET HIS HANDS ON THEIR PERSONAL HANDGUN. THE FIRST LAW ENFORCEMENT OFFICER LEFT HIS LOADED GUN IN THE DOOR PANEL OF HIS TRUCK. WHEN DESHON OPENED THE UNLOCKED DOOR, HE SPOTTED THE GUN AND TOOK IT. WHEN I LEARNED OF THIS I TOOK DESHON TO THE POLICE DEPARTMENT TO TURN THE GUN IN. ON TOP OF BEING CHARGED WITH THEFT OF A FIRE ARM, HE WAS ALSO CHARGED WITH ARMED BURGLARY OF A DWELLING. DESPITE NOT ENTERING THE VEHICLE AND NOT BEING ARMED UNTIL AFTER OPENING THE DOOR. IN THE SECOND INCIDENT IT WAS THE LAW ENFORCEMENT OFFICER'S PERSONAL HANDGUN BECAUSE THAT LAW ENFORCEMENT OFFICER HAD ABOUT 11 GUNS AND HE'D LEFT HIS TEENAGE SON HOME ALONE FOR A WEEKEND AND DESHON WAS INVITED OVER TO THE TEENAGER'S HOUSE BY ANOTHER TEENAGER. ALTOGETHER 9 OTHER BOYS WERE ARRESTED, INCLUDING THE HOMEOWNER'S 19-YEAR-OLD SON. DESHON WAS ONE OF TWO JUVENILES INVOLVED WITH TAKING A GUN FROM THE RESIDENCE. ALL OF THE GUNS WERE RECOVERED. HOWEVER, EARLY ON IN THE INVESTIGATION DESHON DENIED TAKING A GUN; THEREFORE, HE WAS CHARGED WITH 11 COUNTS OF THEFT OF A FIREARM. YES, 11 COUNTS FOR 1 GUN. WHEN WE WENT TO JUVENILE COURT, THE STATE PROSECUTOR WAS PREPARED TO CHARGE HIM AS AN ADULT WHERE HE COULD FACE UP TO 5 YEARS IN PRISON. SO, IN JUVENILE COURT, HE PLEAD "NO CONTEST" AND WAS SENT TO A MINIMUM SECURITY JUVENILE FACILITY FOR 6 MONTHS. SO YOU SEE ON PAPER DESHON LOOKS LIKE A HARDENED CRIMINAL. BUT THE REALITY IS-- HE'S NOT. NOW, IF THE POLICE ARE FOLLOWING HIM, IT'S BECAUSE THEY'VE PULLED HIS JUVENILE RECORD (HE WAS NOT A KNOWN CRIMINAL). THEY WEREN'T FOLLOWING HIM BECAUSE THE EVIDENCE POINTED TOWARD HIM. (AGAIN, THAT'S WHY THEY HAD TO COME UP WITH LIES TO GET THE JUDGE ON THEIR SIDE, AND THEN HOPE TO SCORE.) SO BEFORE SETTLING ON GOING TO SPEAK TO THE POLICE, I INSISTED THAT DESHON COME BACK TO OVIEDO WITH ME. THERE WAS JUST NO WAY THAT I WAS GOING TO LEAVE HIM IN TALLAHASSEE WITH ALL OF THAT GOING ON. HE TOLD ME THAT HE DIDN'T WANT TO GO. I'D ALREADY PLANNED FOR HIM TO TRANSFER DOWN TO VALENCIA COMMUNITY COLLEGE AFTER THE SPRING SEMESTER. DESHON WAS NOT JUST ENROLLED AT TALLAHASSEE COMMUNITY COLLEGE, HE WAS ATTENDING CLASSES, HE ENJOYED GOING TO TCC (PROBABLY BECAUSE HE'D BEEN HOMESCHOOLED FOR THE PAST 4 YEARS), AND HE ENJOYED WORKING AT TACO BELL. IN WHICH I WAS SOMEWHAT AGAINST HIM WORKING AT TACO BELL BECAUSE HE WORKED UNTIL THE EARLY MORNING HOURS AND I KNEW THAT IT WOULD EVENTUALLY BE DIFFICULT FOR HIM TO GET UP IN THE MORNING TO GET TO CLASS. BEING THE MOTHER THAT I AM, ALTHOUGH DESHON AND I WERE IN HIATUS, I MONITORED HIS CLASSWORK ONLINE. AND IF THERE WERE A PROBLEM, I'D ADDRESS IT OR I'D CALL HIS BROTHER WHO WAS A

SENIOR AT FLORIDA STATE UNIVERSITY AND HAVE HIM ADDRESS IT. SO, THINKING BACK OVER THE FACTS SURROUNDING DESHON AND WHY HE SHOULDN'T BE ON THE POLICE RADAR:

- 1.) THE NEWSPAPER ARTICLE STATED THAT A NEIGHBOR SAID THAT SHE'D COME HOME AT 11 p.m. AND SHE DIDN'T HEAR ANYTHING (THEY LIVED IN A TOWNHOUSE SO GUNSHOTS PROBABLY WOULD'VE EASILY BEEN HEARD).
- 2.) FROM LAQECIA'S CELL PHONE A LAST TEXT WAS SENT TO DESHON AROUND 11 p.m. (I KNOW LAQECIA, IF SHE WANTED DESHON TO COME OVER TO SEE HER OR EVEN IF HE TOLD HER THAT HE WAS GOING TO COME OVER TO SEE HER, SHE WOULD'VE TEXTED OR CALLED HIM BACK BEFORE OR AFTER HE GOT OFF FROM WORK).
- 3.) LAQECIA LIVED 19 MILES AWAY FROM THE AREA OF DESHON'S JOB AND WHERE HE WAS LIVING. DESHON DID NOT HAVE A CAR.
- 4.) DESHON'S DNA IS ON FILE BECAUSE OF HIS JUVENILE RECORD. IF HIS DNA IS FOUND IN THE TOWNHOUSE, POLICE NEED TO KNOW THAT HE USED TO LIVE THERE.

THESE WERE ALL FACTS THAT I WAS FOR SURE WOULD HELP THE POLICE NARROW DOWN THEIR SUSPECT LIST. I TOLD DESHON THAT I WAS NOT LEAVING HIM IN TALLAHASSEE WITH THE POLICE FOLLOWING HIM (NOTE: HOW THE POLICE FOLLOWING HIM TOOK PRIORITY OVER MY THOUGHTS OF THE DISGRUNTLE BOYFRIEND BEING THE MURDERER—THAT'S TRAUMA FROM HAVING A DEPUTY PULL A GUN OUT ON ME AND MY FRIEND WHEN I WAS 14-YEARS-OLD AND WE WERE STRANDED AT THE SKATING RING AT 3 a.m. ON TOP OF OTHER INJUSTICES THAT HAPPENED DAILY GROWING UP IN THE HOOD). GOD KNOWS THAT I WAS HOPING THAT MY SONS WOULD NEVER HAVE TO EXPERIENCE ANY TYPE OF INJUSTICES, ESPECIALLY, ESPECIALLY RACISM. DESHON NEVER LIVED IN THE "HOOD". AND I'VE NEVER BEEN ASHAMED OF WHERE I COME FROM BECAUSE I WAS FORTUNATE TO HAVE EXPERIENCED THE BEST AND WORST OF BOTH SUBURBAN LIFE (WITH MY DAD) AND HOOD LIFE (WITH MY MOM). NEVER IN A MILLION YEARS DID I THINK THAT MY SON WOULD EXPERIENCE ALL THAT I'D BEEN HOPING THAT HE WOULDN'T HAVE TO EXPERIENCE AT THE SHERIFF'S OFFICE--JUST A STRAIGHT UP VIOLATION OF OUR CIVIL RIGHTS. WHEN WE WENT TO THE LEON COUNTY SHERIFF'S OFFICE, WE WALKED RIGHT INTO ALL OF THAT MESS.

AFTER DESHON WAS CHARGED WITH 2 COUNTS OF 1ST DEGREE MURDER, I KNOW THAT I NEEDED GOD TO GUIDE ME THROUGH THE MESS. I DID NOT KNOW LAQECIA THAT WELL, AS FAR AS HER FAMILY AND FRIENDS, AND WHAT TYPE OF THINGS OR PEOPLE SHE WAS INVOLVED IN; AND I'D HEARD THAT SHE HAD BEEN ARGUING WITH GIRL ON FACEBOOK—SO I TOOK TO FACEBOOK. ON FACEBOOK I FOUND SO MUCH INFORMATION. FACEBOOK HAS BEEN VERY INSTRUMENTAL WITH

HELPING ME KEEP MY SANITY. I COPIED AND PASTE SEVERAL POSTING OF PEOPLE WHOM I FELT PLAYED KEY ROLES IN LAQECIA'S LIFE. I WAS ABLE TO GET INSIGHT ON HOW THE TYPE OF PERSON SHE WAS AND HOW SHE DEALT WITH PEOPLE, ESPECIALLY HER FAMILY. DESHON AND I WERE NOT AWARE THAT LAQECIA HAD A BOYFRIEND, AND IT WAS ON FACEBOOK WHERE I LEARNED THAT. AND SHE AND HER CURRENT BOYFRIEND WERE ON AGAIN OFF AGAIN. SO WHAT I'VE DONE BELOW IS- I'VE ADDED ACTUAL SNAPSHOTS FROM THE DISCOVERY REPORT AND COPIES OF FACEBOOK POSTS/ COMMENTS TO SHOW SOLID CONTRADICTIONS IN WHAT THE NEWS MEDIA REPORTED AND WHAT WAS JUST A FEW CLICKS AWAY, IF THE DETECTIVES HAD NOT ACTED SO FAST BY ARRESTING DESHON. THE DETECTIVES LIES ARE CLEAR AS DAY. .

*** Fast forward to July 18, 2012, I finally "smelled" the stink with my son's attorney and I told him to fire him. Instead of getting off of the case, his attorney told him that he wasn't going to get off of the case and said that he would finish out the case. He told my son not to worry about his legal fees. Yeah, all of this after I've paid out \$32K. Funny, after his attorney learned that I'd filed a complaint with the Florida Bar against him before I told my, he had no problem getting off of the case. Quick timeline:

--On July 15, 2012, after sending numerous emails to my son's attorney and not getting a response for almost two months (he did not in contact with my son either), I receive an email from him reminding me of an upcoming Pre-Trial hearing.

--On July 17, 2012, my son and his attorney are at a Pre-Trial hearing. Trial was supposed to be for the week of August 13, 2012 but was rescheduled for October 22, 2012. It was the 3rd Motion for Continuance per the State Prosecutor.

--On July 18, 2012, I received an email from my son's attorney saying that once again, Trentin Ross (my son's ex-roommate and State Prosecutor's "key" witness) was not going to be available for Deposition. So now over a year that my son has been locked up, his attorney still doesn't know what this "key witness", whom seems to have my son's freedom in his hands, has to say. Something just doesn't sound right. Then I thought, well, maybe that's it! Just as I figured, Trentin Ross doesn't want to come back to Tallahassee to lie on the witness stand about DeShon. I mean why would he want to really lie on DeShon? Up until DeShon moved in with him, Trentin had been living without electricity in his apartment for nearly a month. DeShon paid his electric bill immediately upon moving in. So that is it—the State Prosecutor can't get Trentin to stick with the statement that they supposedly took from him on February 4, 2011.

--On July 20, 2012, I filed the complaint with the Florida Bar against my son's attorney.

--On August 9, 2012, my son's attorney received a letter from the Florida Bar notifying him of my complaint.

--On August 17, 2012, my son was charged with Conspiracy to Commit Murder against Trentin Ross, the state's "key witness", stating that it was in part of an

investigation that was started in June 2012. DeShon was placed in confinement and his phone privileges were taken away.

--On August 20, 2012, breaking news press release is my son got a hit man to take out "key witness". It's arranged for my son's attorney to express his disappointment and my son and tell people that he's removing himself off of the case. (note: read full articles further below under news article) see below:

[UPDATE] Murder Suspect Accused of Trying to Arrange Hit Man

We talked to Thomas's lawyer too. Greg Cummings says he is disappointed and fears this will delay Thomas's trial. It's set for October 22nd.

Cummings asked the court to remove him as defense attorney before Thomas was arrested on Friday. He cited an ongoing dispute between him and Thomas's mother. He says he was not aware of the new solicitation to commit murder charge until this morning.

****On August 19, 2012, I received this email from my son's attorney. Apparently the State Prosecutor was trying to implements me as to having some part of in the "hit man" scheme. I was not the least concerned about that because I know what I do, what I say and who I say it too. Whereas they have played games with my associates, I know what's going on. I know that they're desperately seeking away out. see excerpt from email below:**

My understanding is that Mr. Williams (no first name available) was told to friend you on Facebook and then he was able to get a picture of Ross. Mr. williams has a pending bank robbery and was out on bond. He is also now a state witness.

The State attorney has told me that you are not a suspect in this offense.

DeShon can no longer have any phone contact or visitation with anyone other than his attorney.

The 17-year-old arrested on charges of first-degree murder in the shooting deaths of a brother and sister in the Wolf Creek neighborhood will be charged as an adult, said Leon County Sheriff's Office spokesman Sgt. James McQuaig.

Deshon R. Thomas already was in Leon County Jail following his Feb. 2 arrest on charges of cultivation of cannabis and possession of paraphernalia, McQuaig said. Detectives learned Thomas was in a relationship with 20-year-old Laqecia Herring and believe Thomas went to the home of Herring and 17-year-old Sterling Conner Jr. to discuss his relationship with Herring, McQuaig added.

First update

An arrest was made in connection with the double homicide of Laqecia Herring, 20, and Sterling Conner, Jr., 17, in the Wolf Creek neighborhood in southeast Leon County.

The Leon County Sheriff's Office arrested Herring's 17-year-old boyfriend in connection with the shooting deaths.

Herring was pregnant at the time of the deaths and LCSO believes that the the suspect went to the home to discuss their relationship.

According to LCSO, the suspect was seen with a gun entering the home on Corey Wood Circle January 27. Check back for updates.

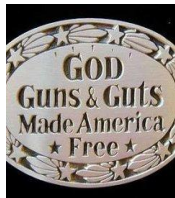

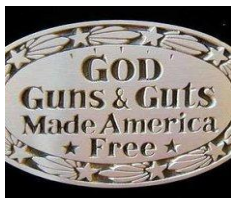

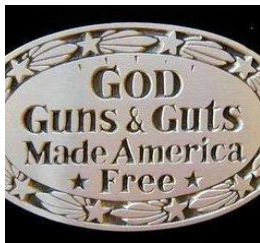

He's accused of killing his pregnant girlfriend and her brother and now he's accused of trying to kill a key witness too.

Deshon Thomas is behind bars, but deputies say that didn't stop him from trying to silence his former roommate who plans to testify against him at his upcoming trial.

Laqecia Herring and Sterling Conner were found shot to death in their Wolf Creek home in January 2011. Herring's boyfriend, Deshon Thomas, is accused of pulling the trigger.

Now Thomas is accused of trying to arrange murder number three and have a key witness against him killed.

"It could have happened at anytime because the person that was supposed to be doing it was in fact ... had made bond and was out," state attorney Willie Meggs said.

Yet the murder plot started coming unravelled right away. A tip led deputies to a fellow inmate. He claims Thomas asked him to kill Trentin Ross when he got out of jail.

He agreed to cooperate with deputies and once released, he proceeded to answer Thomas's calls from the jail. They were all recorded.

In one of the phone conversations, the inmate told Thomas "We're going to get him where he got to be got and get him gone, you understand what I'm saying?"

He went on to say, "We got a bulls eye on the **** ***** ... You gonna beat that trial, you're going to be outta here, you dig?" and Thomas said "Hell yeah."

Another inmate spoke up too and said Thomas passed him six hand written letters while he was in isolation.

Some of those letters were in gang code, deputies say, and outlined Thomas's plan to use a woman to lure Ross to his death and then silence what gang members call a "triple-nine" ... a snitch.

"It will clearly have an impact on the murder case," Meggs said.

We talked to Thomas's lawyer too. Greg Cummings says he is disappointed and fears this will delay Thomas's trial. It's set for October 22nd.

Cummings asked the court to remove him as defense attorney before Thomas was arrested on Friday. He cited an ongoing dispute between him and Thomas's mother. He says he was not aware of the new solicitation to commit murder charge until this morning.

Upon their arrival, deputies discovered Laqecia Herring, 20, and Sterling Conner, Jr. 17, dead inside the residence. Detectives from the Leon County Sheriff's Office searched the crime scene, canvassed the neighborhood and conducted interviews.

Autopsies performed on Friday, January 28, 2011 confirmed that Conner and Herring both died from gun shot wounds. Herring's autopsy also confirmed that she was approximately 21 weeks pregnant. Violent Crimes detectives have continued pursuing leads, conducting interviews, serving search warrants and collecting physical evidence since the bodies were discovered.

During this investigation, detectives learned that Deshon Thomas, 17, had been in a relationship with Herring and she was pregnant. Witnesses also told detectives that Herring had discussed having an abortion, but had changed her mind. Detectives learned that Thomas was seen with a firearm before he arrived at the Corey Wood Circle address in the early morning hours of January 27, 2011. Detectives believe Thomas went to Herring and Conner's residence to discuss their relationship and ultimately shot both Herring and Conner before leaving.

Kendrick Hunter says he can't believe he'll never see 17-year-old Sterling Conner walk through the doors of Life Skills Center in Tallahassee again.

He received a call Thursday about his former student's death.

Hunter said, "It was just devastating once I found out that I actually knew him and I actually spent time with him. I counseled him and spoke with him so many times. It was just unbelievable."

Conner and his sister--20-year-old Laqecia Herring--were found dead inside of their home at 1740 Corey Wood Circle in the Wolf Creek Subdivision off of Highway 20.

Deputies say a family member called 911 around 10:25 Thursday morning.

Detectives confirm that the siblings were murdered, but by who is still a mystery.

Hunter said, "The personality that Conner had, you wouldn't think that no one would do something like that to him. I mean, soft spoken. I don't see why someone would go do that to him and his sister."

Deputies say a one year old child was in the home at the time of the murders. But, say the child was unharmed.

Sharaine Williams is a student at Life Skills. She said, "It's sad to hear that about Sterling and his sister because they were young, and everyone deserves to live. I'm going to pray for his family."

Detectives say the child was safely taken from the scene by family-- family who friends say have lost two young people too soon.

Autopsies are being performed today on the bodies. Deputies say they hope to be able to release more information on how and when Conner and Herring were killed in the next few days.

But, what they didn't tell her was that two bodies were found in the Wolf Creek Subdivision off of Highway 20.

Littles says, "Really? Ah, yeah, they haven't told me anything. That's actually very, actually scary. Living that close and knowing that anything could've happen; my life could've been in danger just as well."

Deputies were called to 1740 Corey Wood Circle around 10:25 Thursday morning... They say that's where they found the two people dead.

Kyle Johnson, a Wolf Creek resident, says, "It's surprising. I haven't had any problems around here before. It seems like a pretty peaceful neighborhood. I've never seen anything like that before."

Deputies say it was a family member who dialed 911...Other family members console each other at the scene as they wait for answers. Forensic specialists search for them in front of the home while a K-9 unit works the back.

Michael Gullage, another Wolf Creek resident, adds, "It's really wierd because since we've lived here there's never really been any cops here. Our neighbors are really nice, we've talked to them. It's just kind of weird."

Deputies have not released any information on the identities of the two people who were found dead... They haven't given their ages...or even if they were male or female.

LCSO reports that two people have been found dead at 1740 Corey Wood Circle off Highway 20 in the Wolf Creek Subdivision. Investigators are calling the circumstances of the deaths "suspicious" at this time. Stay with WCTV.tv for updates.

The 911 call was made by a family member. The two people who died were the residents of the home.

The Leon County Sheriff's Office is involved in a death investigating off Highway 20 at Nena Hills Drive and Corey Wood Circle, according to Sgt. James McQuaig with LCSO. Sheriff Campbell is also at the scene. It is not known if deputies are investigating one death or multiple deaths at this time.
