Detective Don Odham called out to this Detective and advised that he had located a cell phone in the southeastern bedroom. This bedroom is believed to belong to Laquecia Herring. Detective Odham was able to determine that the cell phone belonged to Laquecia. Detective Odham seized the phone as evidence and brought it back to the Leon County Sheriffs Office.

Once back at the Sheriffs Office, I manually went through Laquecia's last text messages that she had received on the 26th of January 2011. Most of the text messages seemed to be sent to or received from the name "Shon" at 850-459-0690. Below is a list of sent and received text messages from Laquecia's phone to the name "Shon".
